In continuation to the notice No. UHF/Regr.(Acad)4-20/2022/-3225-55 dated 27th April, 2022 available on the website, it is for the information of all the candidates desirous of seeking admission in various academic programmes of this University for the Academic Session 2022-23, that in view of inordinate delay in the conduct of Indian Council of Agricultural Research (ICAR)- AIEEA(UG)-2022, AIEEA(PG)-2022 and AICE-JRF/SRF/2022 conducted by the National Testing Agency (NTA), the Competent Authority of the University has taken following decisions in the Academic interest of the candidates:-

- (i) The University will conduct its own entrance test for admission to **Undergraduate Programmes of this University for Normal Seats** exclusively meant for the domiciles of Himachal Pradesh in various centres across the state on **21st August, 2022 (Sunday)** at 11.00 AM.
(ii) The admission to **Self-financing seats at Undergraduate level** shall be filled on the basis of the merit of marks obtained at 10+2 level in the four subjects viz., English, Physics, Chemistry and Biology/ Mathematics.
- The University will conduct its own entrance test for admission to **Master's programme (including MBA-Agribusiness) for Normal Seats as well as Self-financing Seats** in the main campus of the University at Nauni on **28th August, 2022 (Sunday)**
- The University will not make admission to MBA programme for the Academic Session 2022-23.
- The admission to Doctoral Programme will be made in the 2nd Semester of Academic Session 2022-23 (likely to made in the month of December, 2022/ January, 2023 for which a separate notice will be published on the website.

The online application forms will be filled online for which admission notice will be displayed on the website soon. The candidates are advised to remain in touch with the University website.
