- 5. Service provider will have to ensure utmost cleanliness, hygienic conditions and befitting campus like discipline at their allotted space and accessories at all times, wanton neglect of which, shall invite heavy fines including premature termination of the contract. Pest/rodentcontrol should be done regularly. He will keep the shop in a neat & clean condition to the entire satisfaction of the EO/Medical Officer. - 6. The services by the services provider shall be open to use by the University beneficiaries only. Violation of this expressed condition shall automatically land in termination of the contract.
- 7. The University has right to cancel Expression of Interest at any stage. Any kind of dispute will be resolved amicably and in case of any contest, the decision of University shall be final and binding upon both the parties.

TERMS AND CONDITIONS TO BE EXECUTED AS RENT AGREEMENT

- 1. The allotment of the shop will be for a period of three years, subject to extendable for more three years after observing the performance annually. The 10% hike on the existing agreed/fair rent/all amenities shall be applicable in case the allotment is extended by the competent authority.
- 2. The scheduled properties shall remain in absolute possession of Dr. YSP UHF Nauni Solan and the present agreement only allows the service provider to use the premises for agreed purposes.
- 3. The shop should be open from 8 am to 8 pm on all days of the week. In exigencies, the shop will be kept close as per the direction of the University.

- 9. The Service Provider shall start operating the work / services within 15 working days from the date of LOA and shall not carry its business in any other part of the premises.
- 10. The Service Provider shall obtain prior permission of Dr. YSP UHF Nauni Solan, before installing counters and fixtures in the provided space.
- 11. The Service Provider shall pay the fixed electricity and water charges as decided by the University.
- 12. Housekeeping of the allotted space will be done by the agency at their own cost.

- 13. It is the sole responsibility of the Vendor/Franchisee to collect the garbage and dispose appropriately. Under no circumstances, the food waste shall be disposed through the sewage pipes or the drains.

- 15.
